LIABILITY WAIVER AND RELEASE OF CLAIMS:

I acknowledge that I derive personal satisfaction and a benefit by virtue of my participation and/or voluntarism with Redline Cheer & Dance, and I willingly engage in Redline Cheer & Dance events and/or other fundraising activities (the "Activity").

RELEASE AND WAIVER.

I HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE ANY AND ALL LIABILITY, CLAIMS, GROSS NEGLIGENCE AND DEMANDS OF WHATEVER KIND OR NATURE AGAINST REDLINE CHEER & DANCE AND ITS AFFILIATED PARTNERS AND SPONSORS, INCLUDING IN EACH CASE, WITHOUT LIMITATION, THEIR DIRECTORS, OFFICERS, EMPLOYEES, VOLUNTEERS, AND AGENTS (THE "RELEASED PARTIES"), EITHER IN LAW OR IN EQUITY, TO THE FULLEST EXTENT PERMISSIBLE BY LAW, INCLUDING BUT NOT LIMITED TO DAMAGES OR LOSSES CAUSED BY THE NEGLIGENCE, FAULT OR CONDUCT OF ANY KIND ON THE PART OF THE RELEASED PARTIES, INCLUDING BUT NOT LIMITED TO DEATH, BODILY INJURY, ILLNESS, ECONOMIC LOSS OR OUT OF POCKET EXPENSES, OR LOSS OR DAMAGE TO PROPERTY, WHICH I, MY HEIRS, ASSIGNEES, NEXT OF KIN AND/OR LEGALLY APPOINTED OR DESIGNATED REPRESENTATIVES, MAY HAVE OR WHICH MAY HEREAFTER ACCRUE ON MY BEHALF, WHICH ARISE OR MAY HEREAFTER ARISE FROM MY PARTICIPATION WITH THE ACTIVITY. PARTICIPATION AT ANY REDLINE CHEER & DANCE EVENT CONSTITUTES A RATIFICATION UNDER THIS AGREEMENT.

Event Conduct

In order to maintain a safe and enjoyable competitive environment for all attendees, verbal and/or physical abuse, taunting, and distasteful conduct of any kind towards or around staff, athletes, fans, and/or judges will not be tolerated. Athletes are required to attend the event with a parent/guardian, coach, or designated adult (18 years of age or older) that will be responsible for the participant at all times. We are not responsible for supervision of the participant.

COVID-19 SAFETY INFORMATION:

While participating in events held or sponsored by Redline Cheer & Dances "social distancing" is encouraged.. Because COVID-19 is contagious and is spread by person-to-person contact, Redline Cheer & Dance has put in place preventative measures to reduce the spread of COVID-19. However, Redline Cheer & Dance cannot guarantee that its participants, volunteers, partners, or others in attendance will not become infected with COVID-19.

In light of the ongoing spread of COVID-19, individuals who fall within any of the categories below should not engage in Redline Cheer & Dance events and/or other face to face activities. MEDICAL ACKNOWLEDGMENT AND RELEASE.

I agree that if I experience any of these or any other symptoms during the Activity, I will discontinue my participation immediately and seek appropriate medical attention. I DO HEREBY RELEASE AND FOREVER DISCHARGE THE RELEASED PARTIES FROM ANY CLAIM WHATSOEVER WHICH ARISES OR MAY HEREAFTER ARISE ON



ACCOUNT OF ANY FIRST AID, TREATMENT, OR SERVICE RENDERED IN CONNECTION WITH MY PARTICIPATION IN THE ACTIVITY.

As a participant, volunteer, or attendee, You recognize that your participation, involvement and/or attendance at any Redline Cheer & Dance event or activity ("Activity") is voluntary and may result in personal injury (including death) and/or property damage.
